Duties and Responsibilities

The hired candidate will be responsible for the following:

Qualification Required & Experience

Eligible candidates must have the following:

- Bachelor of Commerce, Business Administration, Agribusiness, or relevant tertiary education in business and finance.
- Excellent skills and experience in developing business plans, particularly the financial component of business plans.
- Excellent financial analytical skills (this is non-negotiable, and thus candidates without it will automatically be disqualified).

- Proficiency in Excel, Tally, Quick Books, and other accounting software. At least 5 years of experience in the finance sector (excluding national service).
- Experience and interest in agriculture (related sector), and green economy.
- Mastery in the use of Microsoft Office suite and other related software/applications.
- Fluency in English language, with strong written and oral communication skills.
- Ability to take initiative and work with limited supervision.
- Experience and the ability to work in a team.
